

2026 WESTFIELD PROPERTY TAX NOTICE

This property tax bill includes one perforated coupon attached to the bottom of the tax bill.
Please return this coupon with your payment. This is the only bill you will receive.

DUE DATE:

Due dates for property taxes are voted on at the Annual Town Meeting. **All tax payments are due at the Town Clerk/Treasurer's Office by 4:00 PM on the due date. Postmarks are not accepted.**

- **Payment Due Date: *October 1, 2026 (First Thursday of October, each year)***

An 8% penalty on the unpaid principal will be charged immediately if payment is not received in full by the due date as provided by 32 V.S.A. §1674. Additionally, an interest rate of 1% per month, for the first three months and 1.5% thereafter on unpaid balances per 32 V.S.A. §4873.

ESCROW PAYMENTS:

If your taxes are held in escrow by a mortgage company, you are responsible for providing your escrow company with all the current information included on your property tax bill. If you receive a revised tax bill, it is also your responsibility to inform your escrow company of changes made to your property tax account.

PAYMENTS:

The Town of Westfield offers various options for paying your property tax bill: in-person during office hours, 24-hour wall mounted drop box next to the Town Office front door, mail, online credit/debit card (convenience fees apply) and electronic ACH deposit (e-check) through our website. Our system can receive tax payments weekly, monthly, quarterly or whichever way accommodates your budget, as long as the taxes are paid in full by the due date. Contact us if you need assistance.

POSTDATED CHECKS will be deposited as they are received and will not be held until the date written on the check. Other checks not meeting the requirements will be returned and penalties will be added if applicable. All checks returned by the bank for any reason will cause the payment and receipt to be voided and delinquent penalties will be added, if this occurs after the due date.



PAY ONLINE VIA QR CODE

Point your phone camera at the code to the left and click on the link that pops up to pay your bill online. There is a flat fee of \$1.50 for ACH payments and a 2.65% fee for debit/credit card payments.

FAILURE TO RECEIVE A TAX BILL DOES NOT RELIEVE THE TAXPAYER OF RESPONSIBILITY TO PAY THE TAXES WHEN DUE NOR DOES IT RELIEVE THE ADDITION OF PENALTIES AND/OR INTEREST.



HOMESTEAD DECLARATION/ PROPERTY TAX CREDIT:

Please review your bill carefully to ensure you have filed a HS-122 Vermont Homestead Declaration. Filing HS-122 is how the State informs the town that the taxpayer receives either the homestead education rate or the non-residential education rate. Property owners who qualify and have filed their annual Property Tax Credit Claim/ Household Income (HI-144) with the Vermont Department of Taxes, by the due date, may see a property tax adjustment in the form of a credit on their tax bill. TRANSFER OF PROPERTY:

By law, taxes are levied on the property as it exists for the owner of record on April 1st prior to the start of the tax year. Tax bills are mailed to the April 1st owner of record at the address on file with the Lister's Office.

- If your property is sold after April 1st, it is **YOUR RESPONSIBILITY** to forward the tax bill to the new owner and the new owner's responsibility to take notice of the due dates.
- If your property is subdivided after April 1st, your bill contains taxes due on the entire parcel. It is **YOUR RESPONSIBILITY** to make sure the entire tax bill is paid in full for the year.

You must contact your attorney for prorated taxes or funds being held in escrow on the sale and/or division of the property as our office does not know what arrangements have been made regarding who is to pay the taxes at the time of transfer.

ABATEMENT:

Each taxpayer has a right to apply for abatement of property taxes based on any of the grounds listed in 24 V.S.A. § 1535. Learn more at www.westfield.vt.gov/town-documents-forms. DELINQUENT TAXES:

The Town of Westfield follows a Delinquent Tax Collection policy for collecting delinquent taxes. The purpose of this policy is to establish clear guidelines so that all delinquent taxpayers will be treated fairly and will know what to expect. Provisions of Vermont Statutes will be adhered to in order to ensure that the delinquent taxpayer is afforded the necessary "due process." Learn more at www.westfield.vt.gov/property-taxes.



OVERPAYMENTS:

Overpayments less than \$10.00 will be credited towards next year's taxes; overpayments over \$10.00 will be returned to whoever we received the overpayment from, unless directed differently in writing by the property owner.
