Pat located many supporting statements for the proposed bylaw revisions demonstrating how the proposed revisions are designed to promote the goals identified in the Town Plan.

#### 4. Ordinances- New

# **Review Draft Outdoor Storage Ordinance**

Ellen mentioned that this Ordinance needs to be in order before finalizing the proposal for zoning revisions. The Planning Commission members made some recommendations about specific wording such as removing the phrase "public nuisance" and recommended adding a section to specify the general screening standards for outdoor storage. There would be no outdoor storage in the setback areas, storage from the edge of the setback to 100 ft deep into a lot would require screening, and anything beyond 100 ft could be stored outdoors and would not require screening. Pat will edit the draft to include these changes for review at the next meeting.

### **Review Draft Short Term Rental (STR) Ordinance**

The draft is from the draft Town of Montgomery STR Ordinance. The statutory justification and procedural parts may be at the beginning or the end of the Ordinance. Pat will look to existing Westfield Ordinances for a possible model of the procedural language.

Discussion followed around the impact of STR on housing and when STR becomes a change of use for a parcel (ie no longer a single family dwelling.) Ellen will bring the updated version of the ordinance to the next meeting.
