I. INTRODUCTIONS

II. PROJECT OVERVIEW

i) Project Objectives

The Town described how the project came about at the Planning Commission level because they had recently revised their bylaws for village development and creating opportunities for more density because the state of Vermont is encouraging that in village centers. During one of the has a village center work meetings one of the members mentioned the high water table in the village and that people regularly use a sump pump in their basements. It was also noted that during the Springtime there can be a sewage smell in the Village. Because of these issues, the Town reached out to NVDA, who helped them put together the RFQ. Those present agreed that they're not hearing complaints from community members, but they want to take a proactive approach since it is unclear if community members would voice concerns since there appears to be a mixed public opinion, maybe fueled by fears of costs and an added sewer bill.

The Town's focus is the long-term well-being of the Town/Village. They want the Village to remain populated and be able to take on the maximum density that is allowed by law. But the Town will only be able to do so if they can fix the sewer

issue, so they are focused on creating a strong case to present to the State. They want to explore alternatives besides pumping to Troy/Jay WWTF, including any treatment plant options.

ii) AES Project Approach (see attached)

Kristin revisited the project approach that AES used in our interview presentation. The approach is split into three main phases: investigation & report, design, and bidding & construction.

III. CURRENT PHASE: INVESTIGATION & REPORT

The current phase is the investigation and report phase, which is anticipated to take place throughout 2024. Kristin and Paul reviewed the anticipated timeline and the main components of the preliminary engineering report (PER) outline.

IV. TOWN EFFORT

i) Septic tank and lateral locations

AES discussed with the Town that this project is starting with zero background information, and a big part of this first phase is data collection and field work, which can be a big effort. It was explained that the more the Town and community members can help with some of the prep work, the less effort it will take AES. For instance, we discussed having the homeowners place a flag on/near their septic tank and sewer lateral. Pat suggested having the flags available at the first public meeting.

Paul briefly discussed the five high-potential funding programs for this project, with a focus on the CWSRF as that is the funding available for this phase.

Kristin pointed out that the flyer that the CWSRF published is attached and Paul is available to answer any questions about the program.


